3. HAZARDS IDENTIFICATION

4. FIRST AID MEASURES

Phytomenadione, Vitamin K1, is antidotal. Determine prothrombin times not less than 18 hours after consumption. If elevated, administer Vitamin K1 until prothrombin time normalises. Continue determination of prothrombin time for two weeks after withdrawal of antidote and resume treatment if elevation occurs in that time.

5. FIRE-FIGHTING MEASURES

Suitable extinguishing media Keep fire exposed containers cool by spraying with water if exposed to fire. Carbon dioxide (CO2) alcohol-resistant foam, dry powder, water spray, mist or foam.

Extinguishing media which must not be used for safety reasons Do not use water jets

Special protective equipment for firefighters In the event of fire, wear self-contained breathing apparatus, suitable gloves and boots.

6. ACCIDENTAL RELEASE MEASURES
